- 1. Apologies:

- 2. Previous minutes Action point status and signature Approved. Chairman Bernard Koudjo to sign on his return.
- 3. Estate Security update required from Cecilia Barratt ('CB'). Are the guys doing the fibre installation locking up what they're opening for works? Gate has been open around Wimbledon Park Court and somebody got on the roof recently and the police were called. Safer Neighbourhood Team are to be invited to next General Meeting.
